Principal's Report-Lutheran Schools Music Festival will be hosted by St. Paul, Millington on April 28. Volunteers are needed, please contact Mrs. Walter. Athletic Banquet is May 10 and Academic Banquet is May 28. Accreditation is moving along. Millington Police Chief Oliver wants to visit once a week to greet and visit classes so they know police are good. MSP Trooper Swales, CST (Community Service Trooper) will also be visiting. Jan Snyder has plan to visit newborns and infants to share the love of Christ and encourage church and school. Received a grant for yard signs~they will be seen around town and in the area. Vacation Bible School will be June 26-29. The staff will serve supper to family. Adults will go to one class with students attending another.

Board of Social Concerns-Lunches for Saginaw Rescue Mission are made. New Counselor being considered. Mother's Day Baby Bottle Boomerang will change with bottles as in the past and large bottle banks in Narthex for collection.

Board of Trustees-About a month ago the sewage backed up at the school. We paid about \$1400.00 for materials and the Village footed the rest of the bill. The school office has LED lighting. Adding keycard access to the kitchen door.

Jacob Petzold made a third presentation to Voter's to amend the Constitution of St. Paul that "no future building project may be undertaken while a current building debt exists, unless that project can be funded in its entirety before work begins. If no current building debt exists, the congregation must first raise, at least, 20% of the total estimated project cost.

- 1. A "building project" is any construction that increases the footprint or square footage of our Church, School or any buildings on our property.
- 2. A "building debt" refers to any outstanding loan, line of credit or any money owed toward a past "building project."
- 3. This rule excludes the Parsonage entirely. Any projects there will be subject to normal process within the Board of Trustees."

Moved and supported to proceed with vote. Motion carried.

Moved and supported to amend Constitution, Article VII as presented with "YES" accepting of amendment as printed and "NO" as rejection of the amendment. Diane Mills and Ken McKee appointed tellers.

Vote results: YES 21 NO 15 Motion failed due to lack of majority vote.

Board of Salary & Personnel-Lutheran Benefits representative is coming to explain benefits.

Board of Fellowship & Youth-No report.

Chester Frank requested permission to purchase sewing machine for Dorcas Quilters. It was decided to donate the funds for the purchase.
