Moved and supported to vote Yes for Constitutional Amendment C (Amends Article XI E 2 to replace instances of "Synod" with "The Lutheran Church-Missouri Synod" and to clarify that "for the purposes of this article, The Lutheran Church-Missouri Synod includes both the Synod formed by this Constitution and the Missouri corporation formed by the Synod."). Motion carried.
